Approval of minutes from last meeting and matters arising	Approval of the minutes from the last meeting was received by the Board as a true and accurate record. Apologies were received from Lisa Lyons and George Ralston.	
Payment of BID monies/Finances	The BID has spent £23,892 to the end of quarter 1, against a budget of £88,048 for the year. There are arrears of £7,359; however, businesses are able to pay over 10 months. The claim is operating within budget.	
Projects Update	JH presented 3 quotes to the Board for the landscape improvements to Road Two; the improvements would be similar to those on Road One. The Board discussed various options regarding the cost of improvements and maintenance and decided the 3 quotes were too expensive. JH presented the Board with costing's for the traffic calming signs for Road One. 	Feedback received about the Expo has been good. JH suggested putting a budget in for next year. The Board discussed to option of having an external marketing company plan and run the event. JH informed the Board that there had been no further uptake on the waste management scheme. RR stated that he had utilised the offer to	
	negotiate a reduction in his current contract. This is a progressive scheme.	
	An update was provided to the Board on the Employee Incentive Scheme. JH has been informed that Alison Kelly has now left and is unsure as to whether the Charisma scheme is being promoted.	JH to make contact with Alison Kelly's replacement
	JH met with Derbys to discuss the Blue/Purple Legal Incentive Scheme. The Blue scheme for employees is ready to go; people will receive 30 minutes free advice on any subject except employment law. Derbys are willing to attend AGM to provide more information about the scheme to businesses.	JH to arrange promotion of the offer
	A 'wish list' was established so that the Board could consider projects on a case by case basis. The list included:	
	 Additional CCTV cameras for Road Three and Five – the estimated cost is £7.5K, which included new licence, labour and 2 cameras. Installation of Dog Mess Bins – quotes required for the bins, also the question was raised as to whether the council would empty the bins. Wifi 'hotspots' across the estate – this is estimated at £20K. Look at this option again in year 4 of BID or BID 3. 	Mk to discuss with Streetscene and obtain quotes for the bins
